Fundraising Requirements:

1. Raffle Tickets:

CanSkate - \$100.00 per session, per skater (due upon receipt of tickets)

Families are required to sell 1 booklet of 10 tickets per skater for each session their child is registered. Tickets sell for \$10.00 each.

Pre-CanSkate - \$100.00 per skater for the year (due upon receipt of tickets)

Each family is required to sell 1 booklet of 10 tickets per skater regardless of how many sessions their child is registered.

*If your family feels they can sell more than their allotted tickets, please ask for more!
Prizes will be drawn on March 20, 2021.

2. Tofield Bull Bash or Sodbuster Rodeo Concession - One 4-hour shift in the concession per skater registered.
3. Bottle Drive – Volunteers needed to collect donated bottles and take to the depot.
4. Casino – In the event that the club is given an opportunity for a casino fundraiser, volunteers will be needed.

Volunteer Commitments - Throughout the skating season there may be times we require your help to run events. Ex. Carnival, Potluck, Picture Day. More details about the volunteer requirements will become available closer to the date of the event.

***Note:** Fundraising commitments apply to the first two registrations only.

Cancellation Policy:

Pre CanSkate and CanSkate skaters shall have a two-week probationary period to confirm registration. Withdrawals within the two-week probationary period shall be eligible for a full refund, less the \$60 Skate Canada & administration fee. No refunds will apply if withdrawal occurs after the two-week probationary period.

Covid-19 Shut Down Policy:

In the event that club activities are shut down, any ice sessions left unfulfilled will be refunded less a \$60 Skate Canada & administration fee.

SKATE CANADA ASSUMPTION OF RISK AND WAIVER

PLEASE READ CAREFULLY:

1. ACKNOWLEDGMENT OF INHERENT RISK

I understand that participation in skating, figure skating, and any other sporting activities listed in the enclosed appendix (hereinafter the "Sports Activity") is voluntary, and involves inherent risk during participation, including the risk of possible accidents, physical injury, or exposure to the COVID-19 virus or other infections or infectious diseases as a result of attending training, club events or competitive events. I freely accept and fully assume all such risks, dangers and hazards, including but not limited to personal injury, disease transmission, death, property damage or loss, resulting from my participation. I have carefully considered the risks involved, and I have full confidence that reasonable precautions will be taken to ensure the safety and well-being of myself (or my son/daughter/ward).

2. WAIVER

I do for myself (or my child), and our respective heirs, executors, administrators, successors and assigns, hereby waive, release, and forever discharge Skate Canada and/or Skate Canada: Alberta-Northwest Territories/Nunavut Association (Skate Canada: Alberta-NWT/Nunavut Section), all Regions of Skate Canada: Alberta-NWT/Nunavut Section, Tofield Skating Club, their officers, partners, agents, employees, servants, representatives, volunteers, coaches, officials, successors and assigns (the "Representatives") of and from any actions, causes of action, complaints, demands and claims or any recourse whatsoever ("Claims") that I have or may have in the future in any way connected with my (or my child's) participation in the Sports Activity contemplated herein, whether in law or in equity, in respect of personal injury, illness or disease transmission, loss of life, or property damage of any kind or nature, and I do hereby discharge the Representatives from any such liability.
