## Fundraising Requirements:

1. **Raffle Tickets - \$200.00 per skater (due upon receipt of tickets)**

Each Family is required to sell 2 booklets of 10 tickets per registered skater. Tickets sell for \$10.00 each.

\*If your family feels they can sell more than their allotted tickets, please ask for more!  
Prizes will be drawn on March 19, 2022.

2. **Bottle Drive** – Dates TBA. Volunteers required to collect donated bottles and deliver to the bottle depot.

3. **FundScrip Gift Card Sales**: A minimum of \$200 of gift cards to be sold per skater.

4. **Casino** – In the event that the club is given an opportunity for a casino fundraiser, volunteers will be needed.

**Volunteer Commitments** - Throughout the skating season there may be times we require your help to run events. Ex. Carnival, Potluck, Ag Society events. More details about the volunteer requirements will become available closer to the date of the event.

\***Note:** Fundraising commitments apply to the first two registrations only.

## Cancellation Policy:

Skaters shall have a two-week probationary period to confirm registration. Withdrawals within the two-week probationary period shall be eligible for a full refund, less a \$60 Skate Canada & administration fee. No refunds will apply if withdrawal occurs after the two-week probationary period.

## Covid-19 Shut Down Policy:

In the event that club activities are shut down, any ice sessions left unfulfilled will be refunded less a \$60 Skate Canada & admin fee.

## SKATE CANADA ASSUMPTION OF RISK AND WAIVER

**PLEASE READ CAREFULLY:**

### **1. ACKNOWLEDGMENT OF INHERENT RISK**

I understand that participation in skating, figure skating, and any other sporting activities listed in the enclosed appendix (hereinafter the "Sports Activity") is voluntary, and involves inherent risk during participation, including the risk of possible accidents, physical injury, or exposure to the COVID-19 virus or other infections or infectious diseases as a result of attending training, club events or competitive events. I freely accept and fully assume all such risks, dangers and hazards, including but not limited to personal injury, disease transmission, death, property damage or loss, resulting from my participation. I have carefully considered the risks involved, and I have full confidence that reasonable precautions will be taken to ensure the safety and well-being of myself (or my son/daughter/ward).

### **2. WAIVER**
